**PREPARATION OF THE COUNTY ANNUAL DEVELOPMENT PLAN (CADP) FOR
2020/21 FY**

The County is in the process of preparing the County Annual Development Plan 2020/21 in line with Section 126(1) of the PFM Act which requires every County Government to prepare a development plan in accordance with Article 220(2) of the Constitution. This is an annual plan which identifies programmes and projects to be implemented in a given Financial Year (in this case 2020/21) and is prepared from the County Integrated Development Plan (CIDP).

As per the requirements of various legal provisions including the Constitution of Kenya, County Governments and Public Finance Management Acts, extensive consultations including public participation must be done in the planning and budgeting process.

In line with the aforementioned, stakeholders ranging from members of the public, non-state agencies and other parties are invited to submit proposals on the programmes and projects they would wish included in the 2020/21 FY County Annual Development Plan which will culminate in them being incorporated in the 2020/21 Budget Estimates.

County Integrated Development Plan (CIDP2) 2018-2022

This plan forms the basis upon which the County Annual Planning and Budgeting for the periods 2018/19 to 2022/23 Financial Years will be carried out. The current budget (i.e. 2019/20) is the Second phase of implementing the 2018-2022 CIDP. The third phase of implementation will be in the 2020/21 FY and forms the rationale for the County Annual Development Plan (CADP) currently being prepared.

It is a requirement that County plans and budgets should be within the confines of the approved CIDP implying that all programmes proposed should be from the CIDP.

Copy of the CIDP2 is uploaded in the County website for general downloading and viewing.

County Annual Development Plan (CADP)

Preparation of the CADP is backed by various laws among them the Public Finance Management Act, County Governments Act and the Constitution of Kenya. These laws require County Governments to plan for their Counties and that appropriation of funds to be within the approved planning frameworks. It is from this that the County is preparing the 2020/21 FY CADP.
