MR 6	The underwriter or the proposed underwriter by the broker / agent must submit membership certificate for the current year from the Association of Kenya Insurers (AKI).					
MR 7	The underwriter or the proposed underwriter by the broker / agent must provide audited accounts for the last 2 years (2022 & 2021).					
MR 8	The underwriter or the proposed underwriter by the broker / agent must have done annual gross medical premiums in the last two previous years (2022 & 2021) of Kes 500 million.					
MR 9	The underwriter or the proposed underwriter by the broker / agent must have paid up capital of at least Kes 1 Billion.					
MR 10	 If bidding through a broker/agent one: Must have an authorization letter from the proposed underwriter and the proposed underwriter must meet the requirements MR1 – MR 9 above. Must be registered with the Insurance Regulatory Authority. Must have a professional Indemnity Insurance Cover of at least KShs.100 million. Must be a member of the Association of Insurance Brokers of Kenya (AIBK). Must have Valid tax compliance certificate from Kenya Revenue Authority (tax compliance certificate MUST be valid at the date of tender opening)

MR 14	Tenderer MUST provide Power of Attorney OR a written authorization clearly indicating who the tenderers' authorized representative is. The tenderer's representative must be the one to duly fill and sign all the documents submitted.					
MR 15	Tenderer MUST provide a valid copy of business license/permit (Year 2023) from the County Government where the business is located.					
MR 16	The tender document SHALL: i) Be paginated / serial numbered with pages in the whole document from the cover page numbered in the correct sequence including all appendixes and attachments. The document shall be paginated / serial numbered in a continuous ascending order i.e. sequentially paginated, from the first page to the last in this format; (i.e., 1, 2, 3 n, where n is the last page). ii) Be firmly bound and should not have any loose pages. Spiral binding and files (spring and box) shall not be acceptable. Two (2) copies of the Tender Document, clearly marked original and copy MUST be submitted and an exact replica of the tender document MUST also be submitted in soft copy through the IFMIS GOK Portal www.suppliers.treasury.go.ke.
