#### THE NYANDARUA COUNTY APPROPRIATION ACT, 2025

No. 2 of 2025

Date of Assent: 30th July, 2025

Date of Commencement: See Section 2

AN ACT of the County Assembly of Nyandarua to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2026 and to appropriate that sum for certain public services and related purposes

**ENACTED** by the County Assembly of Nyandarua, as follows—Short title

1. This Act may be cited as the Nyandarua County Appropriation Act, 2025.

Issue of KSh. 9,426,475,236 out of the Nyandarua County Revenue Fund for services of the year ending 30th June, 2026 and appropriation of the money granted

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply for the services of the year ending 30th June, 2026, the sum of Kenya Shillings Nine Billion, Four Hundred and Twenty-Six Million, Four Hundred and Seventy-Five Thousand, Two Hundred and Thirty-Six Only and that sum shall be deemed to have been appropriated as from 1st July, 2025 for the services and purposes specified in the Schedules.

## KSh. 921,345,693 to be applied for County Assembly Services

3. The sum granted out of the County Revenue Fund by sub-section includes the sum of Kenya Shillings Nine Hundred and Twenty-One Million, Three Hundred and Forty-Five Thousand, Six Hundred and Ninety-Three only voted only on account of Nyandarua County Assembly.

#### Appropriations in Aid

4. In addition to the sum granted by section 2, there may be applied for several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriation in Aid under section 132 (2) of the Public Financial Management Act, 2012.
