PRELIMINARIES

The meeting was brought to an order by the Engineer municipality board chairperson MS. Tabitha Wambui. She started by welcoming a member of the public to open the meeting with a word of prayer at 08:40 a.m which was led by Mr Joseph Muragu. After a short introduction done by every member present, H.E the Governor took the follow and started by thanking every person present.

MIN EM 4.12.24/1

H.E the Governor gave the mandate he had given to the Adhoc committee during the time of appointment. The mandate were as follows:

1. To establish the suitable location for the proposed modern market.
2. To establish the most suitable location for the playfield.
3. To identify the most suitable site for solid waste disposal.
4. To identify the ideal location for a bus park.
5. To identify sites for social amenities such as, social hall, library, sewerage treatment, fire station among others.

MIN E.M 4.12.24/2

1. Modern Market

Recommendations:

- **Location:** The committee recommends constructing the new modern market at the **playing field**.
- **Land Requirement:** The proposed market design requires **1.3 acres** for implementation.
- **Relocation Plan:** The committee recommends relocating the **A.C.C residence** currently sitting on the **A.P Camp reserved land** to create space for the playing field.

Progress:

- The National Government has allocated **KSh 390 million** for market construction.
- Due to **budgetary constraints** traders have **not yet been relocated**.
- The county government has involved technical team to establish a workable solution bearing in mind the challenges of relocation at hand, several proposals were presented to H.E Governor and after a careful consideration, the proposal to construct a modern market at the playing field come out as the most viable one.

2. Bus Park and Parking Facilities

Recommendations:

- Maintain the current bus stage location but relocate structures on the road reserve to create more space.
- **Expansion:** Purchase adjacent developed plots for further expansion, subject to owner consent.
- **Alternative Site:** Relocate the bus park to a **0.3 ha parcel** bordering the police station, pending due diligence and negotiations with the Ministry of Interior.

Progress:

- The Engineer bus park has been listed as a priority project under World Bank grant funding. Implementation will commence once funds are available.

3. Solid Waste Management

Recommendations:

- **Dumpsite:** Use the Munyaka parcel for waste disposal due to its centrality and accessibility.

- **Human Resources:** Recruit additional public health officers and garbage collection personnel.
- **Equipment:** Purchase a garbage truck, skip bins, and place bins at strategic points.

Progress:

- Community resistance halted the use of the Munyaka parcel.
- A private piece of land has been identified as a short-term solution, improving waste collection in Engineer.
- 10 M have been set aside for the purchase of a bigger piece of land for dumpsite.
- The municipality, through county funding, has purchased **4 skip bins** as part of solid waste management efforts.
- The county plans to acquire a dedicated skip loader by **May 2025**.
- Long-term waste disposal solutions are under exploration.

4. Show Ground/Playfield

Recommendations:

- Retain the showground on its current **4-acre** land.
- Construct the proposed modern market to the Dias area and push the playing field to the A.P camp site.
- Purchase of other land in future for the stadium.

Progress:

- The committee have involved the registered owner of plot 52 adjacent to the playfield and have agreed to sell that piece of land to county government of Nyandarua in order to have a road buffer of 12 m wide to the proposed modern market and the government offices.

- The relocation of the A.P camp to the land adjacent to Affordable houses site is in a discussion for supplementary budget allocation.

5. Fire Engine

Progress:

- A fire engine has been deployed and is operational, significantly benefiting residents.
