THE 2026 COUNTY FISCAL STRATEGY PAPER**

The County Government of Nyandarua is currently preparing the 2026 County Fiscal Strategy Paper (CFSP) in accordance with Section 117 of the Public Finance Management Act (PFMA), 2012. The CFSP Outlines the key policy and strategic priorities for the County Government in the formulation of its annual budget for 2026/27 FY and the two subsequent years (medium term). The 2026 CFSP will detail the fiscal and policy priorities including revenue and expenditure projections.

In accordance with Article 10 of the Constitution of Kenya, Section 105 of the County Governments Act and Section 117(5) of the Public Finance Management Act which all provide for public engagement and involvement in budget making process, the county government invites the public, private sector entities, stakeholders and interested parties to participate in the public participation consultations for the 2026 CFSP.
