Mwangi Muracia	Secretary Engineer Water project	<ul style="list-style-type: none"> <li>• 90% of grey water disposed in the roads</li> <li>• Most of the pipes are destructed by cattle especially along J30-Mopec road</li> <li>• There is need to endure that grey water does not enter run-off</li> <li>• Majority of the plots are draining the grey water into the open plots thus swamping the land</li> <li>• Most of the roads are encroached</li> <li>• Involve the MCAs in improving the state of sanitation</li> <li>• There is need to redesign the water supply system</li> <li>• Improve the material used (Replace the PVC pipes with more durable materials such as rolls)</li> <li>• Mobilize for resources for the provision of sewer system</li> <li>• Ensure that every plot has a water reservoir</li> </ul>

**MIN 03/28/04/2025: Way-Forward**

The following actions were agreed upon:

1. Fast-track the decentralization of development control to Engineer Municipality
2. Discuss with the top county leadership on sewer system
3. Select a task force to advice on water and sanitation issues
4. Have a round table discussion with various stakeholders in the municipality
