THE 2024 COUNTY FISCAL STRATEGY PAPER

The County Government of Nyandarua is in the process of preparing the 2024 County Fiscal Strategy Paper (CFSP) in line with Section 117 of the Public Finance Management Act, (PFM) 2012. CFSP outlines the broad policy and strategic priorities for the County Government when preparing its annual budget for a given financial year and two subsequent years (medium term). The 2024 CFSP will provide the policy and fiscal priorities for 2024/25 FY and the medium term in terms of revenues and expenditures.

In line with provisions of Article 174 of the Constitution of Kenya on Objects of Devolution, Part VIII of the County Governments Act on Citizen Participation and Section 117(5) of the Public Finance Management Act, the County Government of Nyandarua invites members of the public, private sector organizations, interested parties and all key stakeholders for a public participation exercise for the 2024 CFSP.
